16. EDITORIAL AUTHORIZATION

**CELEBRATING THE 200th ANNIVERSARY
OF THE SUNDAY SCHOOL**

WHEREAS, the Teaching Ministry of the Church (*didache*) is crucial to the church's faith, witness and mission; and

WHEREAS, we benefit from historical reflection when we use the insights among our guidelines in future planning; and

WHEREAS, the year 1980 will mark the 200th anniversary of the Sunday School movement which has

had vast effect on our churches; and

WHEREAS, the observance of this anniversary could be an opportunity for renewing the teaching ministry, for ecumenical dialogue, stimulating research, direction setting and motivation for the future among our churches,

BE IT RESOLVED, that this Twelfth General Synod of the United Church of Christ celebrates the 200th Anniversary of this historic model of Christian Education by officially commending it to the churches as an occasion for renewal and rededication to the teaching ministry of the Church in our time.

**18. RESOLUTION HONORING THE 90th ANNIVERSARY
OF THE DEACONESS SISTERHOOD**

Mr. Myers moved the adoption of the resolution Honoring the 90th Anniversary of the Deaconess Sisterhood, and it was

**RESOLUTION HONORING THE 90th ANNIVERSARY
OF THE DEACONESS SISTERHOOD**

WHEREAS, the Deaconess Sisterhood, begun in St. Louis, Missouri, and having served for ninety years as pioneer professional women of our church in their work as parish assistants, in the establishment of hospitals and schools of nursing throughout the land, as well as Children's Homes, Homes for the Aged and the Emmaus Homes, and

WHEREAS, the whole church is richer through the gifts and grace of these dedicated women throughout these ninety years, and

WHEREAS, there are twenty-nine Deaconess Sisters still living of the more than two hundred who served full-time in this ministry, and

WHEREAS, the vow of obedience, willingness and faithfulness taken by the Deaconess Sisters exemplifies and honors the high calling and commitment of professional women in the church today,

BE IT THEREFORE RESOLVED, that the Twelfth General Synod on this 90th Anniversary commends the Deaconess Sisterhood for its outstanding leadership, dedication and service to the mission of the church and requests the office of the President to convey the gratitude of the whole United Church of Christ.

**19. AFFIRMATION OF UNITED CHURCH OF CHRIST
MEMBERSHIP IN THE WORLD COUNCIL OF
