20. INITIAL REPORT OF EXECUTIVE COUNCIL

The Moderator explained that the Executive Council functions as the General Synod ad interim between the meetings of the General Synod, and their reports would be interspersed throughout the five days of Synod. He called on Rev. Gary Bryant, Chairperson of the Executive Council, to begin the Council's report to the Fifteenth General Synod.

21. RESOLUTION ON THE CLOSING OF YANKTON COLLEGE

Mr. Bryant moved the Executive Council recommendation that the Fifteenth General Synod adopt the resolution entitled, "Resolution on the Closing of Yankton College." Charles Shelby Rooks, Executive Vice President, United Church Board for Homeland Ministries; Dr. Samuel DuBois Cook, Chairperson, Council for Higher Education; and Rev. Jack Batten, Conference Minister, South Dakota.

85-GS-8 VOTED: The Fifteenth General Synod adopts the Resolution entitled, "The Closing of Yankton College."

WHEREAS, Yankton College of Yankton, South Dakota, founded in 1881, closed in December of 1984; and

WHEREAS, Yankton College, the oldest college in the Dakotas, served for over one hundred years as a distinguished college of arts and sciences and conservatory of music; and

WHEREAS, Yankton College was a monument to the vision of Joseph Ward, founder and Congregational leader, and of his wife, Sarah Wood Ward, and throughout its history educated leaders for church, region, nation, and the world; and

WHEREAS, Yankton College, in keeping with its deep sense of mission, provided educational opportunity for men and women of all backgrounds, including students of Native America, Black and other heritages; and

WHEREAS, Yankton College, always faithful in its relationship with the Congregational Churches, the Congregational Christian Churches, and their successor, the United Church of Christ, was an active and responsible participant in the life and work of the Council for Higher Education of the United Church of Christ;

THEREFORE, the Fifteenth General Synod of the United Church of Christ expresses its deep sense of loss at the demise of Yankton College and its equally deep sense of gratitude and appreciation for the contributions of Yankton College, remembering the words of the Apostle Paul:

"Finally, . . whatever is true, whatever is honorable, whatever is just, whatever is pure, whatever is lovely, whatever is gracious, if there is any excellence, if there is anything worthy of praise, think about these things."

(Philippians 4:8);

An audio/visual presentation introducing the mission and

4. INTRODUCTION TO MISSION ISSUES OF REGION

The Moderator introduced Rev. Don Gall of the United Church Board for Homeland Ministries, who then introduced Rev. David O. Ostendorf, Director of Prairiefire Rural Action, a rural education, organizing and advocacy organization based in Des Moines, Iowa. Mr. Ostendorf made the following statement.
