BE IT FURTHER RESOLVED, the Eighteenth General Synod also directs the Office for Church in Society to monitor and to follow up on this resolution, to report progress in UCC publications, and in collaboration with the Hawaii Conference UCC, to report to the Nineteenth General Synod.

AND FINALLY, BE IT RESOLVED the Eighteenth General Synod shares this resolution and follow up study and report with other denominations in order to encourage their support of this initiative of Native Hawaiian self-governance.

# **17. DEBATE EXTENDED**

The Moderator asked the delegates for permission to extend debate for five minutes in order to hear the next Resolution. Permission was granted.

# **1. CALL TO ORDER**

Assistant Moderator Thomas called General Synod to order and recognized Ms. Bernice Powell for announcements.

Mr. Thomas called for the recognition of the Rev. Ray Berry (SD) for his 20 years in Social Service to Native Americans, eight years as an Association Minister, and 14 years serving Native American churches. His spouse Ms. Shirley Berry served as an administrative assistant. The delegates responded with a round of applause.

Ms. Helphrey introduced the Rev. Paul Sherry to speak about the Partnership between the Evangelical Presbyterian Church of Ghana and the United Church of Christ.

Mr. Sherry introduced the Rev. Noah Dzobo of the Evangelical Presbyterian Church of Ghana and his spouse; Ms. Dorothy Gentry Kearney, President, United Church Board for World Ministries; the Rev. Scott Libbey, Executive Vice President, United Church Board for World Ministries; the Rev. Bonganjalo Goba, African Regional Secretary, and invited these guests to join him at the podium.

Mr. Sherry presented a gift of a sterling silver engraved chalice to Mr. Dzobo, who expressed his appreciation for the gift, the invitation to attend Eighteenth General Synod, and the 45 year history of the partnership.

Mr. Dzobo presented a beautiful Ghanian sculpture carved from one piece of wood, expressing our symbolic partnership. Ms. Dzobo presented a banner of hand woven cloth from Ghana as a gift to President Sherry for his hospitality.

Warm applause and a standing ovation celebrated the partnership. Ms. Kearney came forward and led prayer with music.

# 3. STATEMENT ON RELOCATION OF NATIONAL HEADQUARTERS

The Rev. Scott Libbey, Executive Director of the United Church Board for World Ministries, and the Rev. Shelby Rooks, Executive Director of the United Church Board for World Ministries, presented a dialogue responding to questions that had emerged as a result of each of the Board's transfer of funds for the purchase of the new national offices of the United Church of Christ in Cleveland.

The skit included the participation of Ms. Marilyn Breitling, Ms. Lilia Beher, Ms. Lilia Enriquez, Ms. Merlene Bagley, the Rev. Leah Matthews, Ms. Rose W. Lee, Ms. Olivia White, and the Rev. Mary Sue Gast. A beautiful quilt was featured as a tapestry of Coordinating Center for Women's activities.

# 7. INTRODUCTION OF RULES OF DEBATE FOR RESOLUTIONS

Ms. Linda Turner (IS) - Chairperson of the Agenda Committee, explained rules of debate and proposed time limits for resolutions, discussion, and debate. By general consensus, delegates agreed to a time limit of up to 25 minutes per committee report.

# 8. COMMITTEE RECOMMENDATION "MAKE A DIFFERENCE!" FINANCIAL CAMPAIGN

The chairperson of Committee 12 was the Rev. Janis Bassett Dashner (IS). Ms. Dashner introduced the committee recommendation on the Financial Campaign, "Make a Difference!" and moved its adoption.

### MAKE A DIFFERENCE!

BE IT RESOLVED, the Eighteenth General Synod adopts the Finalized Case Statement and List of Needs and the Campaign Operating Plan for the General Synod Special Financial Campaign as recommended by the Executive Council in its report dated June 26, 1991 with the following amendments:

- 1. In the Summary of the Operating Plan for "Make a Difference!" on Page 2, paragraph 1 in the second sentence, add "The Plan calls for" to the beginning of the sentence, and delete the words "will also be necessary."
- 2. In the Summary Case Statement and Needs List for "Make a Difference!" on Page 2, under the section titled "Conference Settings - \$10 million," the first sentence shall read "Conferences bear responsibility for nurturing pastors and congregations."
- 3. Also delete the first word "the" in the second sentence so that the sentence will now read, "They make crucial connections between local and national mission."
- 4. On Page 6 of the Needs List Document in the first paragraph, the last sentence should read, "\$400,000 will be used to bring 'some of' these church buildings and parsonages into good condition."

Further, the General Synod recommends that the plan be implemented forthwith in accordance with the terms of the Finalized Case Statement and List of Needs, and that the administration and implementation of policy for the various monies received, and the campaign, be carried out in accordance with the recommendation of the Executive Council in its report to the Eighteenth General Synod dated June 26, 1991.
